If this DA is approved, it would permit the addition of a single multi-use building, providing opportunities for broader community engagement through Nexus Care's support programs on site and giving the Nexus Samford congregation a permanent home.

How to make sure your support letter counts!

There is a number of details that need to be included for a support letter to be considered a 'properly made submission' according to council requirements.

The letter must:

- be written to **The City of Moreton Bay Council**
- clearly state the development application identifier **DA/2024/3769**
- state your position (see below for more details)
- include the name and residential or business address of the submitter
- have one postal or electronic address for correspondence with the submitter
- be signed by the submitter
- be received during the public notification period (**30 May to 20 June, 2025**).

Stating your position...

Your tailored support letter needs to **state 2 main points**;

1. Your connection to the proposed development. For example, are you:

- A member of Nexus Church?
- A supporter, volunteer or guest of Nexus Care?
- A resident of Samford Valley?
- Supporter of Closeburn Country Garden?
- Frequent visitor to the area?
- Other ie. neighbour, local community member in favour of the development etc.



2. Why you think this development would benefit the Samford community

- Do you believe Nexus Care or Nexus Church has a positive impact in their current communities?
- Are you aware of gaps or needs in the Community that the development could help meet?
- Have you personally experienced the benefits of the community services offered by Nexus Care or Nexus Church, which the wider community would also stand to benefit from should the development be approved?

How to submit your support letter

Once the public notification period is open, you can lodge your letter using one of the methods below:

- Email it to mbrc@moretonbay.qld.gov.au
- Post it to **The Chief Executive Officer, PO Box 159, Caboolture QLD 4510**

Alternatively, you can also

- drop it off at a Council Customer Service Centre, located in
 - Caboolture - [2 Hasking Street, Caboolture](#) (access from Town Square)
 - Redcliffe - [1 Irene Street, Redcliffe](#) or
 - Strathpine - [220 Gympie Road, Strathpine](#) (access from Hall Street)
- upload it to the Council's online portal. To do this, you will need to create a login for *My Moreton Bay* and register for MBRC online services at <https://www.moretonbay.qld.gov.au/Services/Property-Ownership/Moreton-Bay-Online-Services>.
